Understanding the Potential of Flippa


Major online marketplace for website buying/selling. Wide variety of websites available.

- Link to external portfolios or websites for credibility.




Evaluating Blog Potential



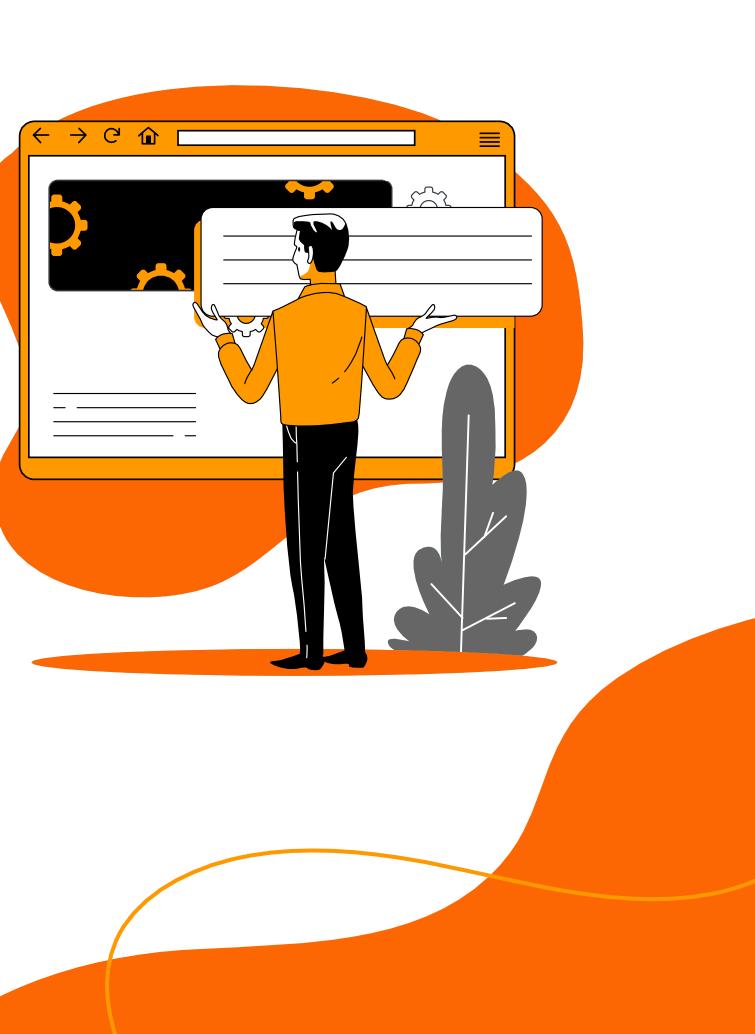
